Fund Overview The Fund is an open-end mutual fund registered under the Investment Company Act of 1940 that seeks to invest in companies with improving returns that, over time, will be converted to higher growth rates. As sub-advisor, Smith Group Asset Management, LLC, employs quantitative and qualitative analysis to identify high quality companies that it believes have the ability to accelerate earnings growth and exceed investor expectations.

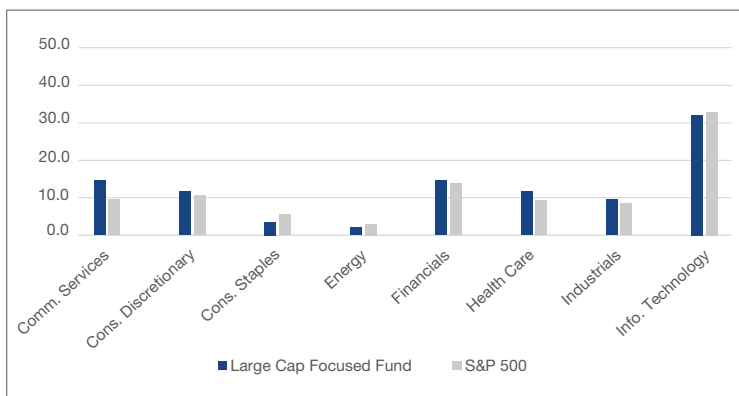

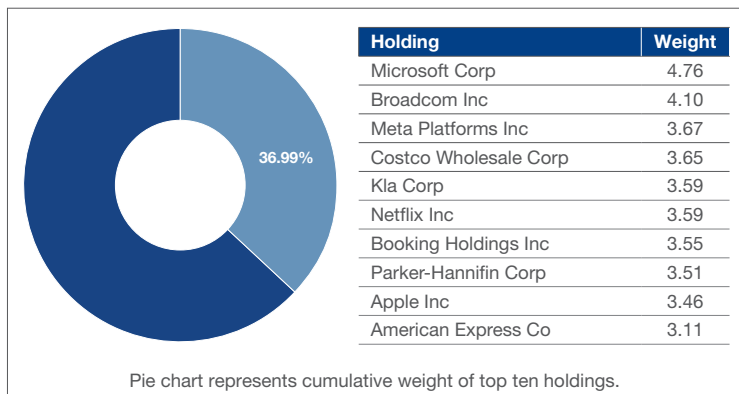

This contractual arrangement is in effect until January 31, 2026, unless terminated by the Board of Trustees of the Fund at any time. Overall Morningstar Rating™ - Morningstar rates funds from one to five stars based on how well they've performed (after adjusting for risk) in comparison to similar funds. Definitions

P/E (price/earnings) is a valuation ratio of a company's current share price compared to its earnings per share. In this case, P/E is calculated using consensus forecasted earnings per share for the next 12-months.

Weighted average market capitalization is a measure of the sum, weighted by Fund position weight, of the total market capitalizations of the Fund holdings. Market capitalization is the sum of the total value of a company's outstanding shares multiplied by the price of one share.

EPS (earnings per share) growth is a measure of the sum, weighted by Fund position weight of the change in earnings per share reported by the company over a specific time period.

Portfolio turnover is calculated as the lesser of the value of all purchases or sales divided by the average of the Fund's total holdings.

Holdings is a count of all Fund holdings excluding any cash or cash equivalents held by the Fund.

Active Share is a measure used to determine how much a portfolio's holdings differ from those of a benchmark index. It quantifies the percentage of a portfolio's holdings that deviate from the benchmark.
